- Grievance Continuation of AJ issue of professional conduct. No contract violation.
- A unit member has expressed that they are being harassed by a FT member.
- Woodland has lost a PT faculty member because of procedures for initial placement and then had their paycheck lost.
- Another Woodland PT faculty member contacted HR because he felt that he was not given a step increase. We helped to discover he was placed incorrectly back a few semesters and is getting back pay.
  - It was suggested that we get a statement from members who we have helped to show what all the Union does for its members. Individual members are reaching out to those they have helped.

# Calendar: Neelam gave report

- For the 2020/21 school year, two options were given out. One had PDD sprinkled throughout the semester, the other had them at the beginning of the semester. Calendar committee members were asked to go out to their constituency and ask for opinions.
  - Discussion at the meeting suggested that the option of having the PDD days sprinkled throughout the semester was the best option for PT faculty.

# Old Business:

- Membership recruitment we are still looking for days to have a membership recruitment event at Woodland campus. An email group will be set up between our Recruitment specialist, Elaine, and Woodland campus reps to find a time to do it.
- WCC Campus rep position
  - The person who was elected to the position at the beginning of the semester has left Woodland campus and that leave a void for a campus rep. Suggestions included having Kris take over responsibilities for Fall semester and hold another election at the Spring meeting, asking members to see if there is anybody else who would like to hold the position.
  - Motion was made by Doug, seconded by Steven to have Kris fill the position for the Fall semester only and have an election in Spring meeting. Motion was passed.
- We need to have more members on the negotiations team.
  - Suggestions for members included a member at Woodland who has had previous experience in Union Eboard and another member at Yuba who was on the managerial union.
  - We are reaching out to those individuals to see if they would be interested in becoming part of the negotiations team.

# Member Input:

- Kris was asked if Office Hours were considered 60 minutes or 50 minutes (lecture hour). Our contract language is not clear, so we are to assume it is 60 minutes.
- Memorial for Jim Kitchen is moving forward. Heidi is having a meeting with the mayor to decide location.
- Doug discussed at the Woodland Academic Senate meeting there was going to be a Guided Pathways committee being established and they wanted to have a PT faculty member on it with compensation.
- Doug discussed at the Woodland Academic Senate realizes that the evaluation of PT faculty is different than those of the FT faculty.
- Doug discussed at the Woodland Academic Senate meeting there is money to hire 2 new FT faculty members and replace the 3 FT current vacancies.
